1. Candidates are advised to report for document verification on **08.09.2025 (Monday) at 9.00 AM at Learning and Development Department (near museum), Digboi Refinery.**
2. The shortlisted candidates are advised to bring the following original documents along with self-attested copies (which were uploaded while filling up the application).
 - a) 10th Pass/Matriculation certificate issued by the concerned education board as proof of date of birth. No other document will be accepted for verification of date of birth.
 - b) SC/ST/OBC(NCL)/ EWS-Income & Asset Certificate by reserved category candidates in the prescribed format issued by Competent Authority.
 - c) Disability Certificate, if any in the prescribed format issued by Competent Authority.
 - d) Class X & XII marksheet and certificate issued by the concerned board.
 - e) Conversion certificate from CGPA/OGPA/Letter Grade to percentage of marks, if applicable, from concerned board.
 - f) Income Certificate (FY 2024-25) issued by Competent Authority on or after 01.04.2025.
 - g) Candidates seeking reservations under Digboi Legislative Constituency are required to produce Permanent Residence Certificate (PRC)/ Voter Identity card of self or parent.
 - h) CEE Scorecard 2025.
 - i) Application form applied in the AOCN Portal
 - j) Any other Certificate, as specified.
3. Without original documents, candidates shall not be allowed to appear for Document Verification.
4. During document verification or at any stage of selection process, in case it is detected that the candidate does not fulfil the eligibility norms and/or that she has furnished any incorrect/doctored/false information/certificate/documents or has suppressed any material fact(s) or is unable to produce original documents or possesses higher qualification, his/her candidature will stand cancelled.
5. The information furnished by the candidate in the online portal with regard to qualification, age, category, CEE score-2025, income details etc. shall be cross-checked from the original documents of the candidates.
6. Please note that during subsequent verification of documents, in case the revelation is contrary to the candidate's claim, candidature will be summarily rejected at any stage of the selection process without any further notice.
7. In case candidate is not meeting any of the criteria of the advertisement No. CSR/B Sc(N)-2025 dated 20.05.2025, candidate is advised not to appear for Document Verification.
8. Candidates whose documents are found to be in order during document verification process shall be allowed to appear for the Pre-Engagement Medical examination (PEME) at Occupational Health Centre (OHC), AOD Hospital, Digboi on 10.09.2025 at 09.00 AM.
9. Only those candidates who are found medically fit in PEME shall be offered engagement letter for admission at Assam Oil College of Nursing, Digboi.



10. Candidates called for Document Verification and Pre-Engagement Medical examination (PEME) shall be required to come prepared and make their own arrangement for stay.
11. Candidates to please note that merely appearing for Document Verification does not confer an offer of engagement to her.
12. Candidature for document verification process is provisional and is subject to her fulfilling the educational and other eligibility criteria mentioned in the advertisement. Mere attending the Document Verification does not guarantee admission at BSc (Nursing) course at Assam Oil College of Nursing, Digboi.
